The annual Mariposa Butterfly Festival 2020 event planning is underway. The Butterfly Festival is a two-day event that takes place in historic downtown Mariposa. The Butterfly Festival is a quality event that brings visitors from around the world. This application covers vendors in the food category. We have a limited number of spaces available for food vendors and we have **CHANGED THE SIZES of booth spaces available this year.**

We invite you to submit an application for a food vendor space. Applications are due by March 1, 2020. See below for space fees based on size. Space is limited so early registration is encouraged. There will be a \$50.00 fee for electric hookups that covers the two day period. We are upgrading our electric this year! No generators will be permitted without the EXPRESS permission of the vendor coordinator. A complete description of the equipment and assurance you have a “quiet generator” would be necessary. Menus are subject to the approval of the Festival Committee.

Show Rules: Set up time is 6:30am to 8:45am Saturday. Breakdown is after 4:00pm on Sunday. All vehicles must be unloaded and removed from vendor area by 8:45 am on Saturday. There will be security on hand Saturday night. Early set up on Friday evening is permitted but no security provided. Vehicles will not be allowed in the booth area until after 4pm on Sunday.

Seller will be responsible and liable for their products, booths and any food sold to the public and agree to assume all liability for loss or injury in connection with their attendance at this event. Seller also agrees to hold harmless the Butterfly Festival committee, the County of Mariposa, the Mariposa County Merchants.

FOOD VENDORS: MARIPOSA COUNTY HEALTH DEPARTMENT PERMITS ARE REQUIRED. NO EXCEPTIONS.
